I, the undersigned, do hereby voluntarily submit my application for registration in *the 2008 Regional TaeKwonDo America Championships*.

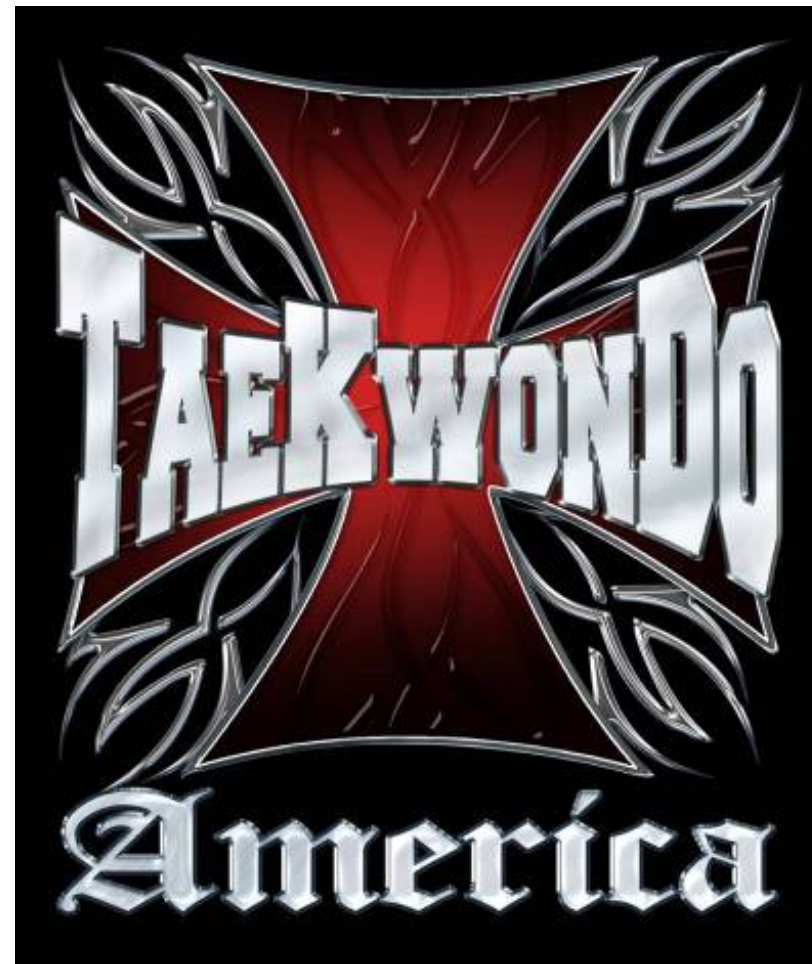
